

# Stadium Lot Parking Agreement

I, \_\_\_\_\_ ("Holder"), in order to be granted a parking permit for the Stadium Lot, located at Kern and H St. ("Facility"), acknowledge and agree that:

1. The monthly parking permit fee is \$10 per month and must be paid through payroll deduction. This fee is subject to change.
2. I will receive one monthly parking permit and one parking gate access card free of charge. The parking permit and access card are non-transferable.
3. Holder must abide by all rules and regulations set forth by ACE Parking governing the Stadium Lot. Currently, parking hours are 6 a.m. to 6 p.m., Monday through Friday.
4. There will be a \$20.00 fee for lost or stolen access card (payroll deduction only). This replacement cost is subject to change.
5. This agreement is not a lease, and no bailment is created between the Holder of a parking permit and Fresno County EOC ("Agency"), its agents or employees, with respect to the Holder's motor vehicle or any personal property contained in the vehicle. This agreement grants the Holder a personal license to park a motor vehicle at this Facility, at the Holder's own risk and in accordance with the terms of this agreement. It is not a guarantee of parking space. The license granted cannot be assigned by the Holder.
6. This agreement is month-to-month, and can be cancelled at any time without notice or reason by either Holder or Agency. Holder must continue to pay the monthly permit fee during any leave of absence in order for this agreement to remain in effect. There will be no pro-rated reimbursement. Upon cancellation of this agreement for any reason, Holder must turn in the parking permit and access card to the Facilities Management office.
7. The Agency, its agents and employees, are not responsible for any loss or damage to any motor vehicle, or its contents, by fire, theft, collision or any other cause. It is the Holder's responsibility to remove all items of value from the vehicle. The Holder hereby releases the Agency, its agents and employees from any and all responsibility in connection with the Holder, the Holder's motor vehicle and the Holder's other personal property. In the event that the Holder suffers any loss to person or property, the Holder shall look solely to Holder's insurance coverage, if any, and shall make no claim whatsoever against the Agency.
